REGULAR TOWN BOARD MEETING
JULY 14, 2022**

The Town of Columbia Town Board held a regular monthly meeting July 14, 2022, at the town building

Supervisor Weiss called the meeting to order at 7:00 P.M.
Pledge of Allegiance

Ray Donley updated the Board on codes and zoning issues. Continues to follow up on Golden Horseshoe Trailer Park issues. Building permit and zoning application calls are increasing.

A **motion** was made by Councilman Cotton, seconded by Councilman Learned, to accept the minutes of 6/09/2022.

A **motion** was made by Councilman Burke, seconded by Councilman Cotton, to accept the Supervisor and Town Clerk monthly reports.

DEPARTMENT REPORTS:

-**HIGHWAY:** Mark updated the Board.

Road paving is scheduled for July 25 & 26

Building project: Base is completed - paved inside. Top crew moved in today.

-**PLANNING BOARD:** Minutes from 6/22/2022 were distributed.

OLD BUSINESS, NEW BUSINESS, DISCUSSION:

-Letter from resident Kay Cotton stating volunteers are mowing cemetery and she wonders if they could receive gas for their mowers. The Board discussed and a stipend could be offered.

Upon motion of Councilman Cotton, seconded by Councilman Burke, the following **resolution #2022-10** was introduced:

RESOLVED: The Town of Columbia Town Board hereby approves a price increase for 2024 Mack Snowplow Chassis from \$174,118.00 approved 3/10/2022 to \$177,618.00 resulting in an increase of \$3,500.00.

A motion was made by Councilman Burke, seconded by Councilman Cotton, to transfer \$5,000.00 from DA201 Highway MMDA to HRA 200 Checking for insurance claims.

A motion was made by Councilman Learned, seconded by Councilman Burke, to transfer \$70,000.00 from F201 Special Fund Savings to A201 General Fund MMDA

VOTE: All members present voted aye.

A motion was made by Councilman Cotton, seconded by Councilman Learned, to appoint Donna R. Wells, Bookkeeper to the Supervisor, to handle all aspects of the American Rescue Plan Act Local Fiscal Recovery Fund Program thru Sam.gov

VOTE: All members present voted aye.

A motion was made by Councilman Cotton, seconded by Councilman Learned, to approve bids of 7/13/2022 Auctions International Sale as per following:

- Ford F350 Pickup, \$41,900.00
- Heavy homemade post pounder, \$10.00
- Gear lube Pump with barrel, \$20.00
- Total: 41,930.00

VOTE: All members present voted aye.

BILLS: The Board audited the monthly bills. A **motion** was made by Councilman Learned, seconded by Councilman Cotton, to accept the following bills:
